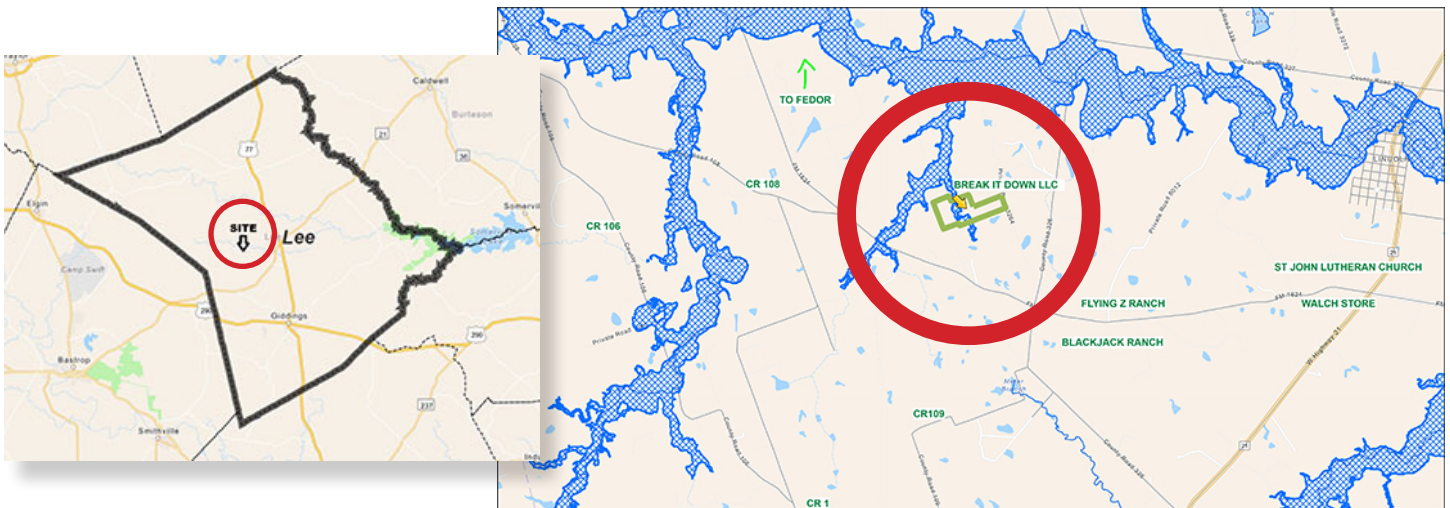

The Risks of a Composting and Waste Plant in Our Community:

Unbearable Odors:

Rendering plants process rotting meat, fish, and animal carcasses, leading to foul smells that can travel miles and cause nausea, headaches, and respiratory problems.

Water Contamination:

Runoff from the plant can contaminate nearby waterways like the Middle Yegua Creek and ultimately pollute Lake Somerville, a vital water source.

Increased Vermin:

These plants attract flies, rodents, coyotes buzzards, wild hogs and other predators, posing a significant health risk to residents.

Property Value Decline:

Living near a rendering plant can negatively impact the value of your property.

A troubling history of environmental non-compliance

Break It Down LLC has a troubling history of environmental non-compliance, having been fined over \$22,500 for repeated violations related to nuisance odors from their composting operations between December 2021 and February 2022.

This track record demonstrates their inability to operate responsibly, posing significant risks to any community hosting their facilities.

Sample Protest Letter

TCEQ Permit No.: 47084

I, along with many of our community members, are extremely worried about this facility coming into Lee County, and I am strongly opposed to the TCEQ Permit No. 47084 request.

The location they are proposing for the facility has run-off that goes directly into the Middle Yegua Creek. This creek is used to water our livestock and crops and more importantly feeds into Lake Somerville which is the main source of water for the city of Brenham in our neighboring county Washington County.

In Lee County our water table recharge level is very shallow, and we are very worried that a facility like this could contaminate our drinking water supply as well.

The roads in our community are not built to handle the traffic of heavy vehicles to get to the facility. This will ruin our roads.

A facility like this will drive people out of our community. The smell, polluted air, polluted creeks, polluted drinking water, etc. will devastate our County. We are a small community and have been working hard to maintain the clean living of rural life.

Composting and waste bring diseases, vermin, poor air quality and dangerous gasses, and is a potential fire hazard.

It is unacceptable for anyone to bring waste materials from the big city (Austin) out to our small rural community and ruin our clean environment.

Lastly, this company "CN604373332 - BREAK IT DOWN LLC" has already been 5 violations in which the TCEQ has had to investigate and remediate. They have received penalties of more than \$20,000 on some of these sites. Now they are trying to move to our community, and it is inevitable that they will do exactly what they did at these other sites. Please don't allow this to happen to our community!

Notice of Intent to Operate a Compost Facility Municipal Solid Waste (MSW) Notification No. 47084

Notification. Break it Down, LLC, has submitted to the Texas Commission on Environmental Quality (TCEQ) a notice of intent to operate a compost facility in accordance with Title 30 Texas Administrative Code Chapter 332 Subchapter B - Operations Requiring a Notification. TCEQ received the application for Break it Down Ranch Rd, MSW Notification No. 47084, on September 9, 2024. The proposed facility will be located at 0.2 miles north on CR 326 from CR 1624, and then one mile west after turning onto Private Road 3264, in Lee County. Accepted source-separated materials will include meat, fish, dead animal carcasses, oil, grease, dairy materials, yard trimmings, clean wood, vegetative materials, paper, and manure from commercial, municipal, and institutional sources.
